DUE TO A HIGHER INCIDENCE OF PROTOZOAN-BASED INFECTIONS AND THE THREE YEAR DROUGHT THAT HAITI HAS BEEN EXPERIENCING, IN 2015, INTERNATIONAL ACTION BEGAN TO ADOPT OTHER METHODS TO ENSURE THAT HAITIAN FAMILIES HAVE ACCESS TO POTABLE WATER.

IN 2015, INTERNATIONAL ACTION BEGAN FOCUSING ON PROVIDING COMMUNITIES WITH NEW SOURCES OF WATER WHEN NEEDED, FOR BOTH DRINKING AND AGRICULTURAL PURPOSES - MANY FAMILIES IN HAITI NEED JOBS AS MOST MAKE LESS THAN \$680 A YEAR.
